**MATERIALS AND SUPPLIES
SPECIFICATIONS AND PROPOSAL**

This Proposal is for provision of building materials and supplies required to perform weatherization services in accordance with Federal Energy Efficiency Standards and Installation Methods. All materials used in provision of services must meet or exceed 10 CFR 440 Appendix A: “Standards for Weatherization Services”.

Vendor is responsible for providing materials to the required specifications and include Material Safety Data Sheets (MSDS) where applicable. If at any time the product(s) do not meet specifications, Agency reserves the right to cancel further orders.

Material purchases may be based on a per job basis or in bulk, at the discretion of the agency. Prices shall be guaranteed “not to exceed” the quoted prices through June 30, 2010, at which time the Agency may solicit new proposals for then current pricing.

The purpose of the quotation is to identify designated vendors that are able to provide frequently purchased materials at competitive prices. Prices shown shall be exclusive of sales tax, although tax may be charged at the time of purchase. The Agency will maintain a “Fair Market Price List” containing pricing of common items from a minimum of three Vendors. The Agency will accept proposals from Vendors who meet the requirements of the proposal process, based on the suitability and availability of materials and supplies, price, and delivery options.
